Important Questions	Answers	Why this Matters:
What is the overall <u>deductible</u> ?	There is no deductible for UC Family providers. For network providers: \$300/person or \$600/family; Out-of-network provider: \$500/person or \$1000/family. The <u>deductible</u> will not apply to network preventive services, physician office visits, rehabilitation or habilitation; network and out-of-network emergency or urgent care, medical evacuation, repatriation or prescription drugs.	You must pay all the costs up to the <u>deductible</u> amount before this plan begins to pay for covered services you use. Check your policy or plan document to see when the <u>deductible</u> starts over (usually, but not always, January 1 <sup>st</sup> ). See the chart starting on page 2 for how much you pay for covered services after you meet the <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes, in-network preventive services, emergency room, urgent care, acupuncture, chiropractic, physician office visits, family planning, medical evacuation, repatriation and prescription drugs	This plan covers some services even if you haven't yet met the deductible amount. A copayment or coinsurance may apply.
Are there other <u>deductibles</u> for specific services?	Yes. Pediatric dental: <b>\$60</b> /person or <b>\$120</b> /family	You must pay all the costs for these services up to the specific <u>deductible</u> amount before this plan begins to pay for these services.
What is the <u>out-of-pocket limit</u> of this plan?	Yes. For UC family providers: <b>\$2,000</b> /person or <b>\$4,000</b> /family. network providers: <b>\$3,000</b> /person or <b>\$6,000</b> /family. For out-of-network providers: <b>\$6,000</b> /person or <b>\$12,000</b> /family. For pediatric dental: <b>\$1,000</b> /person or	The <u>out-of-pocket limit</u> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses.
